Inclusion Support Program

The Australian Government's Inclusion Support Program (**ISP**) provides support to early childhood education and care services (**ECEC services**) to build their capacity and capability to include children with additional needs; providing them with an opportunity to learn and develop alongside their typically developing peers. An Inclusion Agency (**IA**) is established in each state and territory to help ECEC services participate in the ISP.

Under the ISP, eligible ECEC services can access the Inclusion Development Fund (**IDF**), which provides funding to services to address a barrier to inclusion that cannot be resolved by support provided by an IA.

The IDF is administered nationally on behalf of the Department of Education (**the Department**) by the Inclusion Development Fund Manager (**IDFM**). The IDFM is responsible for assessing and recommending an outcome for all applications made to the IDF against the eligibility criteria of the ISP guidelines which are available on the [Department's website](#).

Eligibility requirements of the Inclusion Support Program

To access funding from the IDF, an eligible ECEC service must be seeking to include children with *ongoing high support needs*, including with a diagnosed disability, with additional needs or undergoing/awaiting assessment for disability. Where an ECEC service's application for funding from the IDF is approved, funding will be used by the service to support educators to meet the needs of all children within the care environment of the service.

To enable the service to access funding, the parent/carer must provide documentary evidence that confirms that the child has ongoing high support needs, including:

- additional needs (ongoing high support needs);
- a diagnosed disability (including development delay) or diagnosed medical condition; or
- a current and ongoing assessment for disability.

The ISP requires consent from the parent/carer to disclose this documentary evidence to the relevant IA assisting a child's ECEC service, the IDFM and the Department for the purposes of administering the ISP. The application for funding in respect of a child cannot be processed until this evidence is provided.

Privacy Statement

Your personal information is protected by law, including the *Privacy Act 1988* (the **Privacy Act**), and is collected by the Department for the purposes of administering the ISP. This includes the purposes of submitting, assessing and approving an ECEC service's application for funding from the IDF.

Personal information is information or an opinion about an identified or reasonably identifiable individual. Personal information includes an individual's name and contact details. Sensitive information is a subset of personal information. It includes information or an opinion about your racial or ethnic origin, political opinions, religious beliefs or affiliations, philosophical beliefs, membership of associations or unions, sexual orientation or practices, criminal record, or health, genetic or biometric information.

Personal information collected from you by the ECEC service will be disclosed to the relevant IA assisting your child's ECEC service, the IDFM and the Department, and, if required, your child's new ECEC service following a change in enrolment. Personal information collected from you by the ECEC service will not be disclosed to any overseas recipients.

Information collected and disclosed by the ECEC service to the above entities will include:

- documentary evidence of your child's diagnosed disability or diagnosed medical condition, additional needs, or evidence of current and ongoing assessment for disability;
- whether your child is from a refugee or humanitarian program background; and
- other information about your child's family background that you have provided.

The Department is committed to protecting the privacy of personal information and adheres to the requirements of the Australian Privacy Principles (**APPs**) contained in the Privacy Act. The APPs regulate the Department's collection, use, disclosure and management of personal information. Your ECEC service, the relevant IA and IDFM are also bound by the APPs.
